3. Staff and Committee Updates

- 3.1. Staff Reports
 - 3.1.1. GM Report Grant Parks

Submitted prior to the meeting; highlights follow:

- Workplace Harassment Training board completion update; this training is a requirement for the CPB funding grant and must be completed by the end of September.
- CPB meeting with Rob Davidson, Grant Parks to discuss the grant \$300K Non-Federal Funding Source (NFFS) requirement, which is based on our listening area. This is an urgent matter, and the CPB grant renewal is at-risk. Await decision from CPB. Discussion of contingency planning in the event that the grant is not renewed. Discussion of being in a position to re-apply for the grant next year. Rob clarified that CPB is well aware of impacts of Camp Fire and other disasters on listenership. Grant clarifies that CPB provides \$50-\$70K annually plus additional Community Service Grants (CSG) other federal funds. In the past two years the CSG and additional federal funds of \$400K. Rob comments that the station needs to diversify its fundraising income streams. Grant estimated that the station has received funding from CPB since at least 2012-2013.

- Staffing applications for part-time Office Assistant position being reviewed.
- Ratings presentation on Radio Research Consortium listener survey for Spring 2021/Fall 2020. Grant notes that this survey is available to KZFR at a highly discounted rate courtesy of the CPB grant. Bobbi notes that the National Federation for Community Broadcasters (NFCB) may have additional survey information.
- T-Shirt Design Contest voting underway by public and programmers.
- 3.1.2. Underwriting Report Ray Laager

- August 2021 saw an increase of 20% compared to August 2020.
- October 2021 will see underwriters promoting live performances, which is new.

 - Report mentioned programmer and guest concerns about COVID precautions. Leah mentions that recruiting volunteers is difficult. Rob suggested the Board revisit its COVID guidelines. Jeannie suggested that COVID guidelines be made clear to event volunteers as well. Exec Committee will review.
 - Power of 100 Women award went to the local chapter of the California Court Appointed Special Advocate Association (CASA). Leah mentioned that KZFR has received a few donations from the Power of 100 Women attendees.

 - Grant presents his concern regarding incidents of Covid-19 exposure since July 2021 and revisions of studio guest policy, which was recently updated to allow programmers to have guests in studio.
 - Rob comments that programmers and guests are not using the studio sign-in sheet.
 - Elizabeth comments that quality of some shows is compromised by not having guests.
 - Ray comments that he has been able to use Zoom to book and record guests on his show, echoing a point that Eliane also made.
 - Bobbi comments that Covid-19 guest policy is dependent on programmers to follow the rules and ensure their guests do the same.
 - Courtney clarifies that Butte County Public Health masking policy is at "recommended;" Chico State masking policy is "mandated."

- Dan agrees that it is the programmer's responsibility to comply with and enforce station policy.
- Grant clarifies that there is no station policy that asks anyone to selfattest their vaccination status.
- Rob clarifies that when there is an exposure, it is Grant who sanitizes the station again.
