Comments on Best Practices Document

- The best practices list is pretty good & contains some useful advice. One thing to consider adding: the programmer should put all equipment back to default/normal. That includes any adjustments made to the turntables, the Mackey, or the PC--especially the PC! If you adjust the size display for whatever reason, reset it. Log out of your Facebook or Spinitron account, etc. Thanks.
- Be kind to the other programmer in the Segway between shows. Try to make it as smooth as possible with out rushing them out. . Like, don't take over before their show has ended. ❤️
- try to use positive language, leading with "do"s and avoiding "Don't"s. #4, for example, I'd say, "Limit back-announcing to 3-5 songs because..." etc. rather than "Avoid..." etc. Again in #9, if there's going to be a "Don't do this..." lead with a "Do..."
- Item 3. Too many programmers say the phrases " I just want to let you know ", or " I just want to remind you ", before making their announcement. Just make the announcement. Big T
- My suggestion is to be extra mindful of content (especially right now as the FCC & far right are going after public broadcasting & community radio stations).
 - Beyond just avoiding foul language...if the content is questionable (that's up for debate of course!) but it's best to follow your instinct & omit the song (or artist).
- "Please close any open files or websites on the computer before the next programmer's show."
- if using a Zara playlist, please delete it before the next programmer comes in and close any open tabs on the computer, especially if you're playing music from a website like YouTube, etc.
