Minutes of meeting August 17, 2023, via Zoom
Meeting called to order at 5:03pm

#### **GM REPORT AND GENERAL DISCUSSION**

- Grant reported that he certified two new programmers
- Grant summarized his report on the latest Spring 2023 Nielsen ratings. Some highlights include: since Spring 2022, KZFR's average share has increased from 3.8 to 4.2; time spent listening has increased from 6.75h to 7h/ week, putting KZFR as tied for 6th place out of 35 stations and streams; our highest listening period is M-F, 10am–3pm with an average of 1000 listeners; our biggest increase in listenership occurred Sat–Sun from 6am–12m with an increase from 400 to 600 listeners.
- David suggested we increase ticket giveaways during rating periods as a means to increase listenership; Grant supported that suggestion
- Grant reported that the News Committee is being revived. Grant invited members of the PC who
  are interested to volunteer for the News Committee. Grant also reported that he learned at the
  NFCB conference that a number of segments already broadcast on KZFR (e.g., the Community
  Calendar, Local Update, etc.) already count as "news." Discussion about where we might place
  and how frequent we might broadcast specific segments (e.g., Hightower).
- David reported problems with inaccuracies and omissions with the program logs. Grant reported
  that once the station website is updated, programs logs will be digital. Peter brought up the point
  that if the program logs go all digital, then if the internet goes out, we might be left without logs.
  Grant agreed that that is a valid concern to keep in mind.

### Comments on current programming

- Rob brought up two issues about the timing of Peace and Social Justice show;
  - Talk World Radio starts at 11:30am and is 29 minutes, so there is an extra minute to be accounted for. Grant and the PC suggested that hosts fill that one minute up to the noon hour.
  - Should the Community Calendar on Fridays at begin at 1pm or earlier. The PC agreed that the Community Calendar should start at 1pm as stated on the program log.
- Robert also suggested broadcasting promos for particular segments of programs. Grant thought
  it feasible, but will require advanced preparation and coordination.
